


Static Model in levels to capture long-run effects: OLS with PCSE, Prais-Winsten correction for AR(1)

REPLACEMENT RATES DECLINE EVEN WHEN ABSOLUTE AMOUNTS INCREASE





RESULT: POSITIVE TRADE UNION EFFECT, CONSTRAINED BY RIGHT PARTIES



RESULT: THE HIGHER IMMIGRATION, THE WEAKER IS THE RIGHT PARTY EFFECT



EXPLANATION: WELFARE CHAUVINISM BY RIGHT (EXTREMIST) PARTIES




CONCLUSION: TIMES OF PERMANENT AUSTERITY
